Requirements for the Graduate Diploma of Business:

Accounting specialisation option 1:

Applicants must have successfully completed an accredited post year 12 qualification equivalent to at least two years' full-time study provided that such qualification is deemed sufficient and appropriate on application.

Accounting specialisation option 2:

Applicants must have completed a minimum of at least five years' relevant work experience.

Applicants with overseas academic qualifications in accounting should contact either of the following professional bodies for an assessment of their qualifications (prior to applying for enrolment in the program):

- CPA Australia
- Chartered Accountants Australia and New Zealand.

Information Systems specialisation:

For admission to the Information Systems specialisation applicants must hold at least a two-year diploma from an Australian or other recognised university, or an approved equivalent qualification, in an area other than computing; and have introductory knowledge of computing consistent with that found in the CIS1000 Information Systems Concepts course.

All students are required to satisfy the applicable English language requirements.

If students do not meet the English language requirements they may apply to study a University-approved English language program. On successful completion of the English language program, students may be admitted to an award program.

Program fees

Domestic full fee paying place

Domestic full fee paying places are funded entirely through the full fees paid by the student. Full fees vary depending on the courses that are taken. Students are able to calculate the fees for a particular course via the Course Fee Finder.

Domestic full fee paying students may be eligible to defer their fees through a Government loan called FEE-HELP provided they meet the residency and citizenship requirements.

Australian citizens, Permanent Humanitarian Visa holders, Permanent Resident visa holders and New Zealand citizens who will be resident outside Australia for the duration of their program pay full tuition fees and are not eligible for FEE-Help.

International full fee paying place

International students pay full fees. Full fees vary depending on the courses that are taken and whether they are studied on-campus, via distance education/online. Students are able to calculate the fees for a particular course via the Course Fee Finder.

Program structure

The program consists of 8 courses each of one unit and students must complete either the Accounting specialisation or the Information Systems specialisation.

Required time limits

Students have a maximum of 4 years to complete the program.

Credit
